#### General Meeting, Tuesday, March 11, 2014 Mental Health Improvements Through Early Detection & Treatment, Dr. Steven Adelsheim, MD

### Changes to NAMI Santa Clara County's Bylaws

In the past few years, NAMI SCC has experienced tremendous growth in programs and outreach activity. In order to sustain this level of activity, we now have an executive director and a fully functioning office and paid staff, in addition to our wonderful volunteers.

A board committee has worked during the last eight months on updating our organization's bylaws to reflect these changes. While we have maintained the basic structure of president and vice presidents, committees such as membership, library and newsletter are no longer a part of the board structure. Their functions will be fulfilled by the office staff.

Our current bylaws require that the membership review and approve changes and amend-

ments to the bylaws. ### Call to Action by State Senator Jim Beall

Senator **Jim Beall** is Chair of the California Senate Mental Health Caucus and Select Committee on Mental Health. In this role, he organized a coalition of leaders to make mental health and substance abuse parity a top budget priority. The result is the **Mental Health Parity Enforcement Budget Act**. This act would improve consumer and provider transparency, adopt national standards and force health insurers to submit documented evidence to prove they are complying with the law. Most importantly, it provides the funding to ensure

that regulators have the tools they need to enforce the tougher standards and rules.

To make parity enforcement a reality in Sacramento, Senator Beall needs our help. Write to the Governor and legislators about why the Mental Health Parity Enforcement Budget Act is important to California. Mail, email or fax your support letters to **Hon.
