General Meeting, Tuesday, January 12, 2016 Creativity and Mental Illness, Dr. Sheri Johnson

**Dr. Sheri Johnson** will describe biographical & experimental studies on mood disorders and creativity. Particularly clear evidence suggests that creativity, of many different forms, is high among family members of those with bipolar disorder and those with minor experiences of manic symptoms. Mechanisms and theories about this link will be described.

Dr. Johnson is a Professor of Psychology at the UC Berkeley and Director of the Cal Mania (Calm) Program. She has conducted research on psychological facets of bipolar disorder over the past twenty years with funding from NARSAD, the National Institute of Health, and the National Science Foundation. She has published over 200

manuscripts, including in the Journal of Abnormal Psychology, Psychological Bulletin and the American Journal of Psychiatry. Some coauthored books include Bipolar Disorder for the Newly Diagnosed, Psychological Treatment of Bipolar Disorder and a best-selling textbook on abnormal psychology (Wiley). She is the president for the Society for Research in Psychopathology. Join us in the auditorium of Good Samaritan Hospital (in the basement of the main building) at 7:30 P.M. for an information meeting followed by the presentation from 8-9 P.M. including O&A.

## Talk Therapy and Psychosis

Excerpted from *Our Voice* by Lorraine Zeller, Winter 2016

A talk therapy treatment for psychosis used in Finland, called Open Dialogue, has been successful in reducing the need for antipsychotics. A large study found that only 35% of patients required antipsychotic medication as opposed to those who were treated as usual.

A new report published in October, 2015 in *The American Journal of Psychiatry* and funded by the National Institute of Mental Health, once again illustrates that talk therapy can reduce the need for anti-psychotics. According to *The New York Times*, "the findings from by far the most rigorous trial to date conducted in the United States, concluded the schizophrenia patients who received smaller doses of antipsychotic medication and a bigger emphasis on one-on-one talk therapy and family support made greater strides in recovery over the first two years of treatment than patients who got the usual drug-focused care."

The group on combined therapy, which included one-on-one talk therapy and low dose antipsychotic use, also received help with work or school and their family members received education to increase their understanding of the disorder. The medication doses were kept as low as possible, anywhere from 20% to 50% lower. In addition, subjects who did the best were identified and treated earliest — after the first episode.

According to **Dr. Kenneth Duckworth**, medical director for National Alliance on Mental Illness, the findings are "a game-changer for the field."

This is wonderful news as costs of medications and costs to the health — due to side effects such as weight gain, metabolic syndrome/diabetes, extreme drowsiness, emotional numbing, and decreased ability to self-motivate — of people with psychosis on high doses of these medications is extremely high.

There is hope that people who struggle with psychosis can be empowered to lead a satisfying, joyful and productive life, with appropriate care.

## **Santa Clara County Blue Ribbon Commission**

Dave Cortese, current president of SCC's Santa Board of Supervisors, announced 25 appointees (from a pool of 96 applicants) to serve on the Blue Ribbon Commission tasked to evaluate jail protective custody operations in the county. Retired Judge LaDoris Cordell was appointed as the chair of the commission.

According to Cortese, the appointees "were chosen for their unique perspectives that can move us toward a more holistic approach to better serve and keep inmates, custody staff and visitors safe." NAMI SCC is thrilled that NAMI activists **Navah Statman** and **Hope Holland** are two of the appointed commissioners.

The urgent call to action comes in response to the August 27 beating death of inmate **Michael Tyree** at the county's Main Jail in San Jose. Tyree was awaiting placement in a psychiatric facility. Three

correctional officers face murder charges in connection with his death.

The Blue Ribbon Commission will conduct a series of public meetings to assess where the corrections system is now in terms of policies, procedures and operations and where it should be. The commissioners, who will meet for 120 days, will hear testimony from the public as well as experts. The commission is in the process of setting its agenda, goals and timeline.

The commission is taking public statements at the beginning of each meeting, and NAMI SCC encourages anyone who would like to share their experience to do so. The Commission's meeting schedule is posted on the Santa Clara County website.
